1. Summary and Scope of Work

This CKG is a standing group of research experts in the area of European History, Languages & Literature (EuroBibs). This CKG communicates with and provides support to the UC Libraries Advisory Structure but does not make Systemwide policy decisions, manage projects or project teams, or oversee ongoing services.

The EuroBibs CKG encourages communication amongst librarians and archivists who regularly deal with these subjects to help coordinate evaluation, purchasing, and licensing of current and emerging forms of resources needed to support scholarship and teaching in these aspects of European Studies at the University of California.

2. Key Expectations

This CKG will:

- Gather and share information about the environment, opportunities, new technologies, best practices, and local campus developments within a defined knowledge area.
- Provide input and information to other UC Libraries groups as requested.
- Conceive and advance innovative ideas and improvements relevant to the UC Libraries' Systemwide Plan and Priorities.
- Identify appropriate open access resources to request cataloging by CDL Shared Cataloging Program.
- Identify new online resources that may be of interest to pursue as CDL Tier 1 or Tier 2 acquisitions.
- Coordinate and strategize with one another on active and future shared print and cooperative acquisitions initiatives.
- Leverage separate CRL memberships to vote for major microform sets and multi-volume print publications unavailable in any UC. See CRL [Annual Purchase Proposal Program](#).
